

## Coca-Cola® “Win A Coke Collectible Fridge” Raffle Promotion Official Rules

1. **Promotion Period:** May 7 to July 6, 2018.
2. **How to Enter:** Customers will receive one (1) entry form for every purchase of one (1) case of 300ml Coca-Cola family products. Customers will drop completed entry forms with proof of purchase attached into official drop boxes located at participating Pay-Less Supermarkets.

**No Purchase Necessary:** Entry forms are available without purchase. To receive an official entry form, send a self-addressed stamped envelope to: “Win A Coke Collectible Fridge Promotion” c/o Glimpses Advertising, 161 US Army Juan C. Fejeran Street, Barrigada Heights, Guam 96913. Entry forms are limited to one per person. One request is equivalent to one outer mailing envelope received at Glimpses Advertising. No other non-purchase method of entry is acceptable. Requests for entry forms must be postmarked not later than June 30, 2018.

3. **Eligibility and Restrictions:** Void where prohibited by law. Drawing is open to all legal residents of Guam, 18 years and older.
