- How to Enter:** Entry forms are available on specially marked 12-pack Coca-Cola Family Products. Customers will drop completed entry forms into official drop boxes located at designated drop box locations. Deadline to enter for the weekly drawing is on the Wednesday prior to each Friday drawing. Deadline to enter for the grand drawing is Dec. 26, 2019 at all participating locations except for the grand drawing location, where entries may be submitted up to Dec. 28, 2019. All entries not drawn in the weekly drawings are automatically entered into the grand drawing scheduled for Dec. 28, 2019.

No Purchase Necessary: Entry forms are available without purchase.
